It won't be long before thousands of runners, walkers, strollers and dogs take off through the streets of Regent Square for the 22<sup>nd</sup> running of the Run Around the Square! Here are a few items you may want to know before the great extravaganza takes place!

The popular public radio program, The Saturday Light Brigade (SLB), a Saturday morning Pittsburgh tradition for nearly 30 years, will bring its unique blend of acoustic music and family fun to Regent Square to broadcast live the morning of the race, from 6:00AM until noon. SLB will begin its

broadcast at the finish line for the 1.5 Mile Fun Run/Walk at the corner of Overton and Milton Streets. Then, SLB will move its show to Fern Hollow, the finish line for the 5K Run/Walk, and continue to broadcast and interview participants. You can listen to SLB's broadcast on 88.3 FM (WRCT).

## Regent Square School Closing

*Pittsburgh School Board President to Address RSCA August 2<sup>nd</sup> Meeting*

The Pittsburgh Board of Education has decided to close Regent Square Elementary School as part of its overall redistricting. Students in the Regent Square feeder pattern (Swisshelm Park, Park Place, 14th Ward Regent Square, and small segments of Shadyside) will be assigned to the new Homewood Elementary School this fall.

Middle school students will continue to be assigned to Reizenstein Middle School and most high school students will be assigned to Allerdice Senior High School. No decision has been made as to the disposition of the closed Regent Square School at this time.

Bill Isler, Regent Square's elected representative to Pittsburgh's Board of Education and School Board President, will speak at the RSCA's August 2<sup>nd</sup> Board meeting between 7 and 8PM to address this issue. He will also speak about the elementary, middle and high schools that children in the Pittsburgh portion of Regent Square, Park Place and Swisshelm Park will attend for the 2004-2005 school year, as well as subsequent years. Please let your neighbors and friends in these neighborhoods know about this meeting as this is a topic of interest to many residents of Regent Square. ■

## Zoning Updates

*Pittsburgh Area of Regent Square Slated for Remapping*

As part of the new 1999 zoning code, the City of Pittsburgh Department of City Planning will be remapping the City based on the new zoning districts contained within this ordinance. This applies to the City portions of Regent Square. It is the intention for this new zoning to match existing land uses. Each neighborhood in the city is scheduled to be remapped, with some areas of the City already remapped. This remapping will give recommendations for future use and density for each property within the City, and will affect any future expansion or development. Existing uses will be allowed to remain as they are, sometimes referred to as being "grandfathered in." (Continued on page 3.)

# Frick Park Restoration Stops

## *Nine Mile Run Stream Restoration Halted By Federal Funding Cuts*

Federal funding for the Nine Mile Run (NMR) restoration was cut this year from an expected \$1.6 million to only \$330,000. The contractor, Meadville Land Services, must pull all their workers and equipment out of the work site in a matter of weeks. Although they are doing their best to leave the site as stable as possible by seeding the area with native plants, they are still a long way from finishing the restoration. The Army Corps of Engineers, who are supervising the implementation of the project, are expecting that funding will be cut next year as well, seriously jeopardizing the completion of the restoration of Nine Mile Run.

Nine Mile Run Funding Summary	
Money (Millions)	Description
\$7.7	Total cost of Nine Mile Run stream restoration
\$5.0	Portion expected from Federal government
\$2.7	Portion already provided by City of Pittsburgh
\$3.4	Remaining money needed to complete restoration

If the restoration is left incomplete, the stream will continue to suffer from serious stream bank erosion and degraded habitat for fish and other wildlife and will remain inhospitable for human recreation. Even if the restoration proceeds, but at a much slower rate due to continued funding shortfalls, the stream and park may in fact be in worse condition—sediment will enter the stream during multiple summers of construction, invasive species will colonize the banks in between construction seasons, and park access will be limited.

There will also be some significant additional costs of remobilizing construction crews each summer, reducing the amount of money available for direct restoration work.

Citizen input now can tell the federal government that the community expects the already-promised full funding for the stream restoration reinstated in the next fiscal year.

Senator Specter and Congressman Doyle were early supporters of the initiative. Phone, fax, write, or email them asking for their help in securing federal funding to ensure that this important restoration in Frick Park is completed. In this election year, also consider writing to both presidential candidates.

As part of this rezoning there will be a community meeting at which the Planning Department will give its recommendations based on a survey of existing land uses. This meeting will present an opportunity for the City residents of Regent Square, defined as the area south of Forbes Avenue, to give comment prior to these recommendations going to the City Planning Commission. The City has asked the RSCA to sponsor this meeting, which is planned for mid-September. In addition to the City residents getting a notice from City Planning, the RSCA will notify residents of the time and place when this is set, both in the next newsletter and on the web site. ### *Keep A Lookout Milton/Trevanion*

There have been several petty thefts to homes/cars in our community. One resident on Trevanion had two wicker chairs taken from her front porch. A few doors away, a double stroller taken. Over on Milton, a jogging stroller stolen. Other neighbors report break-ins on Macon.

It only takes a minute for someone to drop in and make off with something valuable. And secure any valuable things left outside such as expensive furniture, lawnmowers, grills and bikes.

## Local Notable

### *In Memoriam - Dr. Edwin L. Harder*

Few people would know that Dr. Edwin L. Harder was the holder of 66 patents. This Regent Square Resident left us on 24-May-2004 at the age of 99.

A longtime Westinghouse employee, he did some pioneering work in the field of computer development. Many computers were built originally for electric-power applications. Dr. Harder worked with these systems. At Westinghouse, he was responsible for the development of **Anacom**, (analog computer) in 1948, which had the capacity to model a complete power system. It continued to be used until 1991! Several of his patents helped to keep Westinghouse solvent during the Depression years.

He was written up in the book "*Sparks of Genius: Portraits of Electrical Engineering Excellence*," by Frederik Nebeker, New York: IEEE Press, 1994, p. 159-199.

His neighbors knew him from his daily walks. Few people would know from his manner that he had made so many contributions to science, many of which allow us to have reliable electric power at our command.

An avid reader of the Newsletter, he put pen to paper and gave the community an amusing look at the squirrels near his house. He had them trained to fetch treats and do tricks. All of his neighbors, including his furry friends, will miss him. Should you wish to express your sympathy, the family suggests that he would be honored to be remembered by a contribution to a charity of your choice. ■

### *WSCC Pursues Updating Play Area*

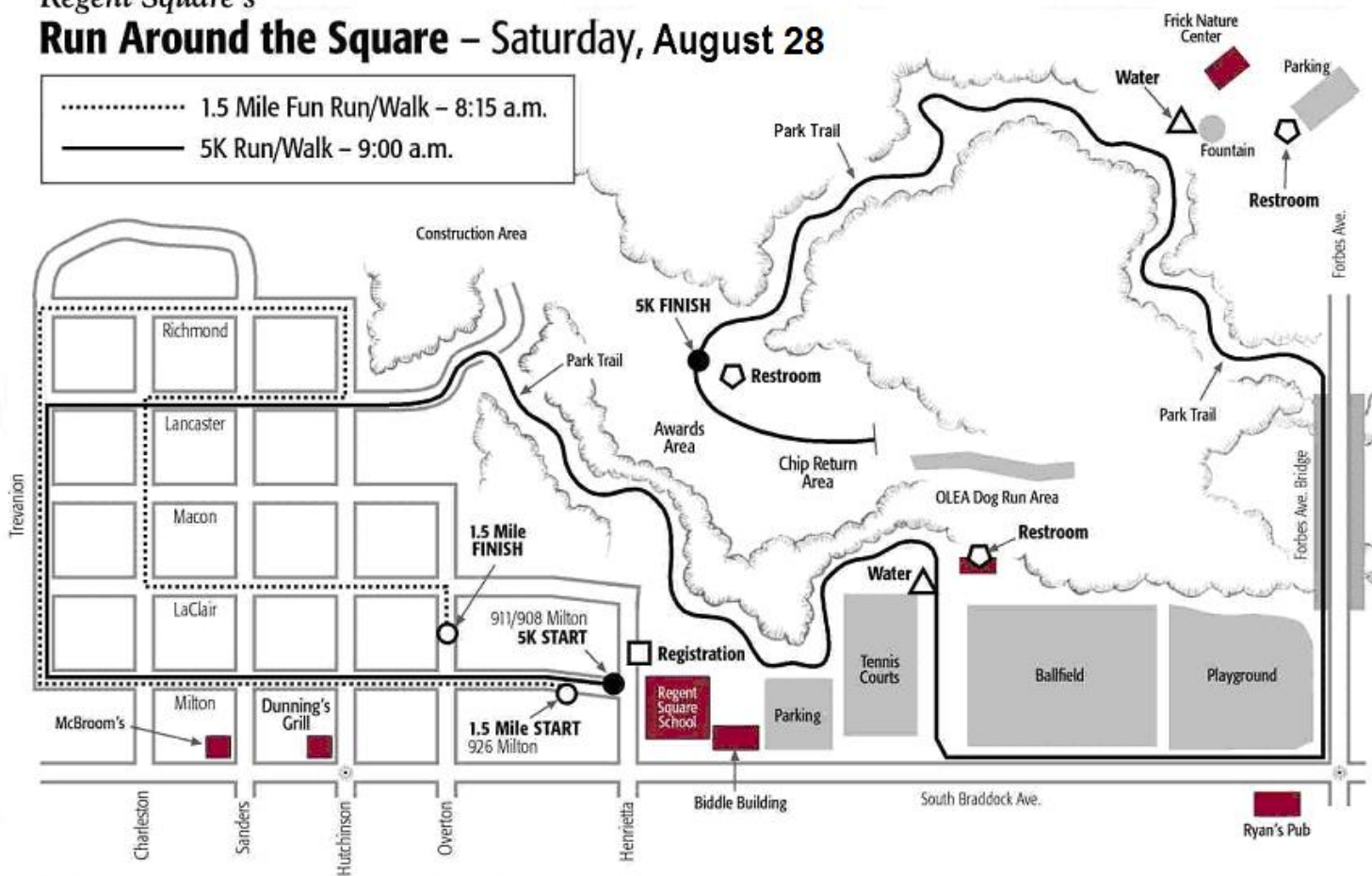

## Be Wary of Loose Dogs

### How To Recognize And Prevent Canine Catastrophes

With warmer weather come more of our neighbors—and our dogs—outside. But a good dog is also a dog under your control. What should you do if an out-of-control dog approaches you and your dog? You may have seconds to react, so knowing ahead of time what to do can make a huge difference.

First, see what your dog sees: • Do the dogs have their tails up (we haven't agreed who's the boss)? Tucked (I'm scared)? High and stiff (tense and not covering scent glands)? • Is the approach very slow and stiff (neither is submitting)? Very fast (testing how well you'll guard your personal space)? • Is either dog growling deeply?

It's always a good idea to turn around and walk the other direction. But if you saw any of the signals above, you may be about to prevent a fight: • In a low voice, deeper than the growls, say, "Leave it!" or "Out of here!" while clapping your hands. The goal: break the attention. Do your best to relax; the dogs will react to your level of tension or anxiety. • Toss a big handful of treats past the dogs (and give a bunch to yours as you lead it away). Your goal: distract them. Maybe the aggressor will decide the treats are better than a fight, giving you and your dog time to leave. • Move in the opposite direction from the other dog. Pull the leash down and back, not up. Your goal: add distance between the dogs; move away from the aggressor's perceived territory. • Praise and treat your dog for any attention in your direction away from the other dog. Your goal: reinforce you're the most rewarding and interesting thing out there.

And if a fight ensues anyway, break it up safely and remove your dog as soon as possible: • Call your dog loudly, intensely, and seriously—no high-pitched or hysterical voices. Your goal: bring your dog back to you. • Put something physically between the dogs other than you. Anything will do—a garbage can lid, a bag, a jacket. Your goal: distract and separate. • As a last resort, grab the aggressor's hind leg or the base of the tail, either part as close to the body as possible. When you have a good grip, lift and back up.

Finally, assess the damage. When it has relaxed again, check your dog all over.. If you find anything unusual, consult your veterinarian. If you get bitten, see your doctor. And report the aggressive dog to the police. ■

# South Braddock Avenue Update

*Continued Focus By RSCA – Progress To Report*

The Braddock Avenue Improvement Committee has some very visible, and some not so visible changes to report!

Last month, we reported that the RSCA had applied for a Department of Community and Economic Development grant and we should hear something soon. This grant would allow us to take one or two of the critical steps needed to move toward implementing the Vollmer recommendations.

A big thank you to Doug Shields and the City of Pittsburgh who followed through on their promise to purchase and install center-line “flags” to mark the crosswalks along the city portion of Braddock Avenue. Their presence has definitely slowed traffic.

I've seen pedestrians crossing between the crosswalks on several occasions. This is a dangerous situation, defeating the purpose of the crosswalks. Pennsylvania law states:

“When traffic-control signals are not in place or not in operation, the driver of a vehicle shall yield the right-of-way to a pedestrian crossing within any marked crosswalk or within any unmarked crosswalk at an intersection.”

No pedestrian shall suddenly leave a curb or other place of safety and walk or run into the path of a vehicle which is so close as to constitute a hazard.

Every pedestrian crossing a roadway at any point other than within a crosswalk at an intersection or any marked crosswalk shall yield the right of way to all vehicles upon the roadway.”

A lot of work has gone into marking the crosswalks to make them safer. Please do your part and use the crosswalks! No traffic or roadway changes substitute for pedestrians using caution.

Look for a less visible but equally important change with respect to the timing of the light at Braddock and Hutchinson. The Vollmer recommendations were to put the

“Walk” cycle between the Braddock and Hutchinson green signals, allowing increased green signal time for both South Braddock and Hutchinson, without decreasing the length of the Walk signal. This makes it easier for both pedestrians and vehicles. The borough of Edgewood will be making this change soon.

Get involved! So far we have had no volunteers for a subcommittee to develop priorities related to which intersections get emphasis, nor have we had any responses about the trees. The RSCA is a group of volunteers; we need your help!

Ending on a positive note, thanks to word-of-mouth we heard from a professor at CMU who thought this might be a good project for some of his students. We'll be pursuing that offer for help.

Thanks for everyone's patience as the Braddock Avenue Committee keeps focused on this long-term project to improve our community. Have a happy, safe August! ■

## Walking Tour

### *Frederick G. Scheibler, Jr. Houses*

*Article author and Regent Square resident Henry “Saint” Tucker is a sales associate for Neighborhood Reality Services, which has their offices on South Braddock Avenue in the Square. He and his wife are restoring their own house, one of the three Frederick Scheibler houses located at the corner of Milton and Trevanion Avenues on this tour.*

The Square is full of architectural treasures, not the least of which are the works of Frederick G. Scheibler, Jr., who was perhaps the most important original architect from Pittsburgh, certainly in the progressive movement. Like most of the Arts and Crafts “greats” of MacIntosh, Voysey, Adolph Loos, and Frank Lloyd Wright, Scheibler was a progressive individualist of the early 20<sup>th</sup> century. Scheibler himself never actually lived around here, but many of his clients did, and others either worked or invested here. Some of the finest ex-

amples of his works can be found within walking distance and make an excellent walking tour.

You can begin at the present Wilkins School, an appropriate place, since the present structure stands on the site of an original school building that was one of Scheibler's early commissions from the Swissvale School District, a big parochial client of his. The original school, built in 1907, was destroyed by fire and replaced by the current structure.

Just a short half-block from Wilkins School on Trevanion Avenue at the corner of Milton are three white stucco houses which are good examples of Scheibler's “artistic house.” The largest, at 7510, was built in 1915, and is one of the “crown jewels” of this period. The triangular roof lines are of particular interest, as well as the exterior stone patterns underneath. The leaded and art glass windows are similar to those in many houses you will encounter, and on the side, there is a circular rose motif window on the stairway landing.

The middle house, 7508, is a small cottage that was built by the clients of 7510 in 1922 for a family member. The five long leaded windows in the front let in plenty of natural light and their design shows some hints of a possible Frank Lloyd Wright influence. The triple iris window in the side is actually not original to this house, but is authentic to Scheibler: it was rescued from a dumpster at another Scheibler apartment complex, restored, and brought here by the current owner. This house is undergoing a complete restoration.
